(MGL Ch. 53 §9A)

Last day for Nomination Papers to be filed with the Board of Registrars:

Tuesday, February 14, 2023 at 5:00 pm

INSTRUCTIONS:

- Town-wide candidates (incumbents and challengers) must obtain a minimum of 50 signatures from registered voters. The Clerk strongly recommends all candidates **obtain additional signatures**.
- Non-incumbent Town Meeting Representative candidates must obtain 25 signatures of registered voters from the precinct they wish to represent. The Clerk strongly recommends all candidates **obtain additional signatures**.
- Town-wide candidates are entitled to eight (8) blank nomination papers. Town Meeting Representative Candidates are entitled to four (4) blank nomination papers.
- Town-wide candidates must remember the following Campaign & Political Finance obligations:
 1. Before incurring any expenses or receiving any funds they must file a **Statement of Organization**.

 2. All local election candidates and incumbents will be asked to register for the **Office of Campaign and Political Finance Department Reporter 7 Program**. This program will be used to file the required 8 Day, 30 Day and Year End OCPF Reports. Please follow this link to register: <https://ocpfreporter.us/LocalFilerSignup>
 3. **Your first OCPF (Office of Campaign and Political Finance) report is due on Monday March 27, 2023 - eight (8) days before the election.**
 4. **Your second OCPF report is due on Thursday, May 4, 2023 - thirty (30) days after the election.**
 5. **Even if you incur no expenses and raise no money, you are still obligated to sign the CPF M 102-0 report in the Office of the Town Clerk, both eight days before and thirty days after the election.**

Please be aware that you have an obligation to file
all necessary paperwork with the Clerk's Office.
